NOTICE OF PRIVACY

What personal data are collected and for what purpose?

Your personal data will be used in order to register participants in the training actions, validate attendance at the courses, provide training, generate the corresponding records, prepare reports, make statistics, where appropriate, establish communication for follow up on the conclusion of the courses, training programs; as well as to clarify doubts about your data, whether due to any error or inaccuracy, notification of cancellation or change of schedule, date and / or location.

Additionally and only in case the participant authorizes it, the contact information provided in the attendance lists will be used to send information about training actions or events of this direction that may be of interest to you.

For the aforementioned purposes, the following personal information is collected:

- Full name
- Gender
- Email
- Phone
- Rubric
- Labor data (name of the Institution or Obligatory Subject to which it belongs, area of nomination and position).

It is reported that the data collected is not considered as sensitive data in accordance with the applicable provisions.
